

Terms and Conditions for Ticket Purchasing by Instalments
Reading Festival Weekend Ticket – Second Release Plan 4 March start

1. Tickets for Reading Festival can be bought by paying the purchase price over four instalments. Payment by instalments is available to any customer buying a ticket between 00:01am Wednesday 1st March 2023 and 23:59pm Friday 31st March 2023 (the “**Eligibility Period**”), subject to ticket availability. The first instalment must be paid within the Eligibility Period.
2. The full price of your ticket purchase being £265.00 per ticket, a per ticket service charge of £21.20, and a per transaction handling fee of £3.25 will be charged as follows:

Instalment	Amount	Payment Due
First	£66.25 per ticket, a per ticket service charge of £21.20, and a per transaction handling fee of £3.25	Charged immediately
Second	£66.25 per ticket	On or around 1 st May 2023
Third	£66.25 per ticket	On or around 1 st June 2023
Fourth	£66.25 per ticket	On or around 1 st July 2023

3. All Instalments are non-refundable and no claim can be made to recover this money in any way whatsoever other than in accordance with clause 11 of Ticketmaster’s Purchase Policy and clauses 13-16 of the Reading Festival Terms and Conditions. The first instalment includes a per ticket service charge and per transaction handling fee, which, subject to the foregoing, are also non-refundable.
4. The first instalment will be charged to your credit or debit card immediately upon your purchase of the ticket during the Eligibility Period. Each subsequent instalment will be automatically charged to your credit or debit card on or around the due dates set out in paragraph 2, without further recourse to you. If your card is declined, you will be contacted for an alternative card. Any alternative card must belong to, and be in the name of, the original purchaser. If we are not provided with an alternative card within 5 days of the due date, your ticket(s) will be void, and you will not receive a refund for any instalments already paid (including service charge and handling fee).
5. You agree to pay the full ticket price plus the service charge and handling fee when the first instalment is transacted. The transaction will be completed only once your payment of all instalments has been processed and the total is paid in full.
6. If you do not pay any of the instalments in full by the dates set out in paragraph 2, and we are not provided with an alternative credit or debit card within 5 days of the relevant due date where the original method of payment provided is declined (as per paragraph 4), you will lose (i) all

instalments (including service charge and handling fee) already paid and (ii) the ticket(s) will be void.

7. It is recommended that you ensure that adequate funds are in place to process the payment of all instalments on the dates set out in paragraph 2 and that your credit or debit card does not expire before the final instalment can be charged.
8. Tickets cannot be refunded or exchanged after purchase, save as provided in Ticketmaster's Purchase Policy referred to in paragraph 9 below.
